**PHASE-3 GOLDEN CARNAUBA APPLE COATING HAS BEEN DESIGNED FOR USE IN COATING FAIR SKINNED VARIETIES BOTH DOMESTIC AND EXPORT MARKETS**

**DIRECTIONS:** PHASE-3 CARNAUBA SHOULD BE APPLIED IN ITS ORIGINAL UNDILUTED STATE BY USING GENERALLY ACCEPTED INDUSTRY METHODS. OPTIMUM RESULTS MAY BE ACHIEVED BY A THOROUGH CLEANING OF FRUIT WITH APPROPRIATE U.S. SYNTEC PHASE PRODUCTS IN THE DUMP TANK AND BRUSH SECTION AS NEEDED. FOLLOW WITH A CLEAR WATER RINSE AND COMPLETE DRYING PRIOR TO WAX APPLICATION. LOW BRUSH SPEEDS WITHOUT SACRIFICING COVERAGE ARE RECOMMENDED. IN THE EVENT OF FOAMING, MINIMAL AMOUNTS OF FOOD GRADE SILICONE ANTI-FOAM MAY BE ADDED DIRECTLY TO THE WAX OR IN A WATER DILUTED SOLUTION SPOT SPRAYED ON BRUSHES WHERE NEEDED. PRODUCT SHOULD BE GENTLY STIRRED, DO NOT USE SHEAR MIXING!

## PERSONAL PROTECTION



### First Aid

**If on skin or clothing:** Take off contaminated clothing. Rinse skin with plenty of water for 15-20 minutes. Call a doctor for treatment advice.

**If inhaled:** Move person to fresh air. If person continues to experience discomfort, consult a doctor for further treatment advice.
